Join us on the second annual North American Trail Ride Conference (NATRC) Leisure Division Ride to be held at the Concord Mt. Diablo Trail Ride Association (CMDTRA). This ride is an introductory ride with the purpose of introducing the rider to the sport of competitive trail riding. It also gives experienced NATRC riders an opportunity for a "leisurely" ride. It is one of the most beautiful rides you will have this Spring! We have ordered SUNNY weather from Mother Nature this year!

This is a competition ride sanctioned by NATRC and conducted under their rules. The ride will consist of fire roads and single track trails and some hill climbs. The length of the ride will be between 8-12 miles. The pace is an approx. average of 3 - 4.5 miles per hour. Horses may compete with boots or hoof or leg protection. There is a possibility of small water crossings. There will be P&R checks and obstacles that will be judged. An NATRC approved judge will observe and evaluate the horse and rider as a team.

This ride offers you the ability to check in and out the same day, although we encourage you to camp overnight on Friday and/or Saturday and ride the trails on Sunday on your own. Camp opens at 12:00 pm on Friday (no early arrival requests please). Camping and stabling will not be judged, but overnight stabling will be evaluated for safety. There is an additional charge of \$15 per night per horse (non-riders \$5/night) to stay overnight. The Rider check-in will start at 8:00 Saturday morning and the ride will be completed by mid-afternoon. There will be a rider briefing prior to hitting the trail. Bring your own snacks for the trail on Saturday. A light snack will be provided in the clubhouse after the ride. There is no meal planned for Saturday night.

Attn: Juniors! This year, a contribution of \$30.00 towards the \$60.00 Entry Fee for each junior will be made by the Diablo Equestrian Heritage Association (DEHA). DEHA is a non-profit organization that supports educational events about the heritage of the horse in the Diablo area. The \$30.00 dollar entry fee for juniors on the entry form reflects 50% off the \$60.00 entry fee (DEHA will pay the other \$30.00 of the entry fee directly to CMDTRA on behalf of each junior). We'd like to encourage you to send a thank you note to DEHA for supporting your introduction to the sport of competitive trail riding. SUGGESTED ITEMS TO BRING: Manure fork, heavy duty garbage bags, horse blankets, buckets, saddle, bridle, halter, lead ropes, hay, fly spray/bug repellent, sponge, leather punch, grooming articles, hoof picks, wrist watch (for trail pace timing), alarm clock, knife, rain gear, pencil/pen, headlamp/flashlight and batteries, personal toiletries, camping gear, water bottle, drinking water, lunch/trail snacks for ride. Don't forget fix-it materials like duct tape and first aid supplies.

<u>SEND ENTRY FORMS AND FEES TO</u>: You may register directly on line via RMS (automated system) at http://rms.natrc.net / but you must also use the enclosed/attached ride entry form and mail it to: NATRC Ride Secretary, 4632 Adams Drive, Concord, CA 94521. Make sure the NATRC Rider liability waiver form, the California liability waiver form and the CMDTRA liability waiver form are signed and mailed <u>along with the entry form</u>, and enclose your check made payable to <u>CMDTRA</u> for the full amount.

Awards: First through sixth Place awards for Experienced, Adult and Junior class Horse-Rider teams. See NATRC Rule Book 4 A 4 e. Certificates awarded for 1st through 6th places for Experienced, Adult and Junior Horse-Rider Teams



<u>GENERAL INFORMATION:</u> Hay or other feed is not available for purchase. All minors under 18 years of age must be accompanied by an adult in camp. Riders 12 and under must ride with an adult sponsor or a junior sponsor 13 or older with more than 250 NATRC miles, with a limit of two per sponsor. <u>ALL RIDERS ARE ENCOURAGED TO WEAR HELMETS.</u>
<u>JUNIORS ARE REQUIRED TO WEAR ASTM/SEI, SNELL OR APPROVED EQUESTRIAN HELMET AT ALL TIMES WHILE</u>
<u>MOUNTED</u> (1) IN CAMP, (2) ON THE TRAIL, OR (3) ON CMDTRA PROPERTY. ABSOLUTELY NO SMOKING ON THE TRAILS.

- A saddle is required but no restrictions as to type.
- It is our recommendation that your horse be shod or wear hoof protection. Some trails are rocky. There are no shoeing restrictions for the Leisure Division ride.
- Stabling must follow NATRC rules. Most riders tie to a trailer or use overhead ties. If you are camping overnight with us, a pipe stall may or may not be available for you to use depending on soil moisture level. Camping and stabling will not be judged but will be evaluated for safety.
- Stallions must be ridden by adults only, must be well-mannered and stationary double tied when tied.
- Bring tools to clean around your stabling area. Use the clear manure bag(s) provided for your use in gathering up manure, and put the bag into or next to the designated truck/trailer. Do not scatter manure in the bushes! We won't have Sumo wrestlers available, so please do not to make the bags of manure too heavy!
- Horse water is provided in camp. Please use the dipping buckets and do not allow horses to drink directly from any troughs.
   Potable water available in the clubhouse (kitchen faucet—bring your own bottle)
- NO OPEN FIRES ANYWHERE
- Dogs must be on leash; no loose or noisy dogs. Riders with noisy or loose dogs will be asked to leave the ride. Dogs are not allowed on the trails, in the clubhouse or the pool area, in official management areas or at P&R stops.
   See www.natrc.org/download.php?code=DOG\_POLICY CMDTRA dog policy also applies.
- Shower and toilet facilities available at pool house facilities. Porta-potties in camping areas.
- Immunizations for ALL HORSES MUST BE CURRENT. Out of state horses must have a health certificate and negative Coggins certificate (within 6 mos.)
   There will be an on-call veterinarian, however, there is no guarantee that they will be available at any given time. We will try to have a farrier on call.
- Camping is available at \$15.00 per horse per night (\$5 per non-riders per night)
- ALL NON-RIDERS MUST CHECK IN AT THE CLUBHOUSE TO SIGN A LIABILITY WAIVER.
- ALL riders are expected to attend the ride briefing and need to pay attention to timing. The judge is on a tight schedule to get to several locations to see everyone—long gaps between first and last riders become problematic.

VIOLATORS WILL BE ASKED TO LEAVE

<u>680 Southbound:</u> Treat Blvd exit, turn left at end of off-ramp and then immediate left onto Treat Blvd. Continue on Treat 4 miles to Clayton Rd. Right onto Clayton Rd. See additional directions below.

<u>680 Northbound:</u> Treat Blvd. exit, turn right at end of off-ramp onto Treat Blvd. In approx. 4 miles, turn right onto Clayton Rd. See additional directions below.

<u>Hwy 4:</u> Harbor/Railroad Ave exit, go south on Railroad (it becomes Kirker Pass Rd, which has a very steep incline—(**Use Willow Pass Rd to Clayton Rd. to avoid steep incline**). Turn left onto Clayton Rd. See additional directions below.

From all directions above as you travel southeast on Clayton Rd, you will pass through two intersections named Marsh Creek Rd - do not turn on either one. As you pass Diablo Middle School, Clayton Rd becomes Marsh Creek Rd. Continue on Marsh Creek Rd., go one mile past Regency Rd (the last stoplight leaving Clayton). Turn right onto Russelmann Rd, also called Russelmann Park Rd, a "T" intersection with a sign saying "CMDTRA." (If you reach Rodie's Feed or Morgan Territory Rd, you went too far - turn around, go back approx 1.2 miles to Russelmann).

Westbound on Marsh Creek Road: Turn left onto Russelmann Road, also called Russelmann Park Rd, a "T" intersection approx 1.2 miles past Morgan Territory Road. If you reach Pine Ln, you went too far turn around and go back approx. ½ mile. See addt'l directions above. Follow the ribbons up the mountain. Drive very slowly over both cattleguards. Russelmann becomes Trail Ride Rd. as you enter CMD-TRA grounds. Turn right at the "clubhouse" sign and follow ribbons and signs to the designated parking areas.

IF YOU ARE HERE WITHOUT PERMISSION AND HAVE NOT SIGNED THIS AGREEMENT, YOU ARE TRESPASSING AND WILL BE REQUIRED TO LEAVE IMMEDIATELY.

- 2. <u>Consideration</u>: Guest wishes to visit or has been invited to Premises privately owed or managed by CMDTRA and will be engaging in various activities, including but not limited to equestrian activities. In consideration, Guest agrees to release, hold harmless and indemnify CMDTRA from all claims as set forth in this Agreement and agrees to all terms set forth herein.
- 3. Limitation Of Liability and Assumption Of Risk:

- By signing below, Guest releases CMDTRA of all liability in connection with any injury sustained as a result of Guest's activities on or around any horses and for any other activity occurring on Premises including but not limited to swimming, hiking, and sports of any kind. Guest also acknowledges that horseback riding and horse handling is an inherently risky activity and hereby releases CMDTRA from any liability for injury, damage, or loss to Guest or Guest's equipment. Guest understands that visitation to an equestrian property is inherently risky and assumes the risk of being on Premises. Guest understands that CMDTRA is not responsible for any accidents, personal injuries of any type, damages, or loss to Guest or to Guest's personal property, in conjunction with being on Premises or in conjunction with horse activity and other activity of any kind. Guest expressly understands that horseback riding, training, instruction, clinics, shows and related activities are inherently dangerous, including inherent risks which cannot be eliminated. Guest hereby asserts that her/his participation in this Agreement and any activity whatsoever on Premises is completely voluntary and Guest expressly assumes all such risks, all risks of injury of any kind, including death and all risks of injury, loss or damage to Guest's personal property of any kind, including loss, damage or injury to Guest's horse(s), if any. Guest agrees to use best judgment to always take safety first into consideration while riding a horse. Guest further acknowledges that CMDTRA cannot be responsible for certain occurrences and elements of nature that can scare a horse, cause it to fall, or react in some other unsafe way. Some examples are: thunder, lightning, rain, wind, water; wild and domestic animals, insects, and reptiles which may walk, run, fly near, bite, or sting a horse; irregular footing on outdoor, or indoor groomed or wild land, all of which is subject to constant change in condition according to weather, temperature, natural and man-made changes in landscape. Guest promises not to sue or bring a claim of any kind for any personal injuries sustained or any damages to personal property sustained, including loss, damage or injury to Guest's horse(s), (if any) as a result of such natural occurrences. Guest also fully understands that CMDTRA does not carry insurance on Guest's horses, nor are Guest's horses covered under any public liability, accidental, injury, theft, or equine mortality insurance, and that all risks connected with being on Premises with a horse, are to be borne by the Guest. If Guest's horse(s) injure any other persons, other animals or damage any property on Premises, Guest understands that they are responsible for any claims arising there from and will also defend, indemnify and hold harmless CMDTRA from any such claims.
- 4. <u>Indemnity and Waiver of Unknown Claims</u>: Guest agrees that s/he will defend, indemnify and hold harmless CMDTRA against all claims, demands, liabilities, and causes of action including court costs, expenses and attorney's fees, directly or indirectly arising from any action or other proceeding brought by, or prosecuted for, Guest's benefit or for the benefit of Guest's heirs, guardians and assigns or brought by others, against CMDTRA in connection with being on Premises or any action or inaction taken by Guest, Guest's family members, agents, heirs or assigns. This extends to all claims of every kind and nature whatsoever, whether known or unknown. Guest expressly waives any benefits s/he may have under Section 1542 of the California Civil Code relating to the release of unknown claims. Guest understands that this law contains provisions designed to prevent Guest from waiving unknown claims that existed at the time of waiver, and Guest expressly agrees to waive all rights that Guest might have under this law and related sections
- 5. <u>Damage to Premises:</u> Guest agrees to pay for and/or repair any damage that occurs to Premises, including but not limited to all personal property, buildings, barns, fences, stalls, pens, structures or vehicles caused by Guest or by Guest's horse (s).
- 6. <u>Rules</u>: Guest agrees to follow any rules or signs posted on Premises. Guest also agrees to follow any instructions given by CMDTRA or their agents, assistants, employees or independent contractors working on behalf of CMDTRA.
- 7. Attire and Helmet Use: Guest, if horseback riding, agrees to wear appropriate riding attire and CMDTRA strongly recommends wearing an ASTM certified helmet. CMDTRA <u>does not</u> permit riding without an ASTM approved safety helmet for minors under age 18. <u>No exceptions.</u> Violators will be subject to a fine of \$ 150.00 if observed violating this requirement for the first offense. For a second offense, violators will be subject to expulsion from CMDTRA and from its premises without the possibility of re-admittance.
- 8. <u>Adult Helmet Waiver</u>: CMDTRA <u>strongly</u> encourages and suggests all riders to wear an ASTM approved safety helmet at all times while riding a horse.
